Chairman of Ministry Procurement Committee on behalf of SriLankan Airlines hereby invites sealed bids from eligible and qualified bidders under the International Competitive Bidding method (ICB) for the Renewal of Type-B Messaging Services at SriLankan Airlines.

Minimum Qualifications of the bidder:

- 1.The proposal shall fully comply with the IATA Type B messaging standard and all related protocols. Detailed documentation demonstrating adherence to these standards should be included.
- 2.The Bidder shall have a minimum of 5 years of industrial experience specifically in providing Type B messaging platforms within the aviation industry. Evidence of this experience should be submitted with the proposal.
- 3.The Bidder shall demonstrate a proven track record of successful project implementations of similar or higher capacity. At least five successful cases, each documenting the project's scope, implementation, and outcome, are required for evaluation.
- 4.The Bidder shall provide proof of financial and economic capacity. This should include audited financial statements for the past three years. Submission of these financial documents is mandatory.
